### 1. PURPOSE AND IDENTIFICATION

### 2. FIELD OF APPLICATION

These general terms and conditions apply, to the exclusion of any other provision, to any registration of one or more participants, professional or private, hereinafter referred to as the "Participant", in a Training Course organized by EOMYS.

- 2. The fact of registering Online for a Training Course implies unreserved acceptance, in their entirety, of these general terms and conditions of sale.
- 3. EOMYS reserves the right to modify the terms of these conditions. Only the general terms and conditions of sale in force on the day of registration will apply to the registration in question.

## 3. REGISTRATION - CONTRACT

- 1. Registration for the Training Courses is possible by completing the form directly online on the training.eomys.com website.
- 2. Full payment of the registration fee is to be made upon registration with EOMYS and by online payment at <a href="https://www.training.eomys.com/">https://www.training.eomys.com/</a>. All registrations are due. Any entry for which the file is incomplete or not accompanied by payment under the conditions specified in Article 5 below, will not be considered.

- 3. Once EOMYS has received the registration and payment, EOMYS will send the Participant a summary validating his or her order and his or her registration for the chosen Training Course (the "Order Confirmation").
- 4. In case of training held by teleconference: For on-line registration to distant training, it is not allowed to participate with more than one person for each registration. By registering for the training, you must agree to our terms and conditions of service which stipulate this condition. If you want to register with several trainees at same connection location, please contact EOMYS for a customized quotation.

If EOMYS is unable to follow up on the Participant's registration request (due to a too late request or a problem of availability), EOMYS will inform the Participant and refund the registration fee within 21 days by transfer to his bank account.

The contract shall be deemed concluded when <u>EOMYS sends the Order Confirmation</u>, subject to receipt of payment.

### 4. RETRACTION - MODIFICATIONS - CANCELLATIONS

- 1. The participant has a right of withdrawal which he can exercise within 14 calendar days from the order confirmation without having to give a reason. The registration fee will then be refunded in full, if it had been cashed, by bank transfer within a maximum of 21 days.
- 2. If the 14-day withdrawal period mentioned above has expired and the Participant wishes to cancel his/her participation in the Training, he/she shall inform EOMYS by e-mail.

EOMYS will proceed to the eventual reimbursement according to the following conditions:

- Cancellation up to 31 working days before the course: full refund, minus a 50€ handling fee.

- Cancellation less than D-15 working days before the event: no refund (except in cases of force majeure with proof).

### 5. Conservation
